PLAYERS CODE OF CONDUCT

We acknowledge that;

1. Play by the rules – the rules of your club and the laws of the game
2. Never argue with an umpire or other official – without these people you can't play football
3. Control your temper - verbal abuse of officials and sledging other players does not help you enjoy or win any games
4. Be a team player – It's a team game, treat it that way
5. Treat all players as you would like to be treated - fairly
6. Co-operate with your coach, the umpires and team-mates
7. Play for your own enjoyment & to improve your skills
8. Don't use ugly remarks based on race, religion, gender or ability – you'll let down your coach, team-mates and family if you do – & many such comments are actually now illegal

PARENTS, SUPPORTERS & OFFICIALS CODE OF CONDUCT

1. Remember that you are there for the participants to enjoy the game
2. Encourage participation, but don't force it
3. Teach that enjoyment is more important than winning
4. Never ridicule mistakes or losses – supporters are there to support not downgrade
5. Lead by example and respect all players, coaches, umpires and spectators – physical or verbal abuse will not be tolerated
6. Recognise all volunteers who are giving up their valuable time
7. Never publicly criticise umpires – raise personal concerns with club officials in private
8. Don't use ugly remarks based on race, religion, gender or ability – you'll let down your family and yourself if you do – & many such comments are actually now illegal

1. I will respect the rights, dignity and worth of all individuals within the context of my involvement in Australian Football, including refraining from any discriminatory practices on the basis of race, religion, ethnic background, or special ability/disability.
2. I will abide by and teach the AFL Laws of the Game and the Rules of my Club and League/Association.
3. I will be reasonable in the demands I make on the time commitments of the players in my care, having due consideration for their health and well-being.
4. I will refrain from any form of personal abuse or unnecessary physical contact with the players in my care.
5. I will have due consideration for varying maturity and ability levels of my players when designing practice schedules, practice activities and involvement in competition.
6. I will stress and monitor safety always
7. In recognising the significance of injury and sickness, I will seek and follow the physician's advice concerning the return of injured or ill players to training
8. I will endeavour to keep informed regarding sound principles of coaching and skill development, and of factors relating to the welfare of my players
9. I will at all times display and teach appropriate sporting behaviour, ensuring that players understand and practise fair play.
10. I will display and foster respect for umpires, opponents, coaches, administrators, other officials, parents and spectators.
11. I will ensure that players are involved in a positive environment where skill learning and development are priorities are not overshadowed by a desire to win.
12. reject the use of performance enhancing substances in sport and will abide by the guidelines set forth in the AFL DRUG POLICY.

EXPECTATIONS OF PLAYERS AND FAMILIES

It is expected that all players and parent/ guardians are responsible for meeting the requirements outlined by the Longwarry Football Netball Club:

1. Football players or parents/ guardians of players are to undertake a number of duties, including but not limited to, scoring, time keeping, setting up and packing up of the Football field & Change rooms on game day and canteen duty throughout the season on a rotational basis as organised by club individuals. Which will be communicated to players and families prior to the commencement of the first home game.
2. Players, parents/ guardians who cannot undertake their rostered duties **are responsible** in organising or "swapping" with another individual to cover their duty. This change needs to be communicated to the players' coach/ team manager so changes can be made to the roster in advance.
3. It is the clubs' expectation what you as a player have committed the whole season to playing at the club; we understand that sickness, injury and some absences are unavoidable during the season.
4. It is your responsibility to inform your coach about your availability. This means that players, including injured players are expected at all trainings unless otherwise advised. Apologies must be sent to individual coaches before the commencement of the scheduled training time.

5. Each coach may have their own way of dealing with unexplained absences; the club supports the coaches' right to use their discretion on game time, if a player has not attended training without an explanation.
6. The club expects you to arrive at training and game day with enough time to prepare yourself for the session/ game, including bringing the correct uniform and products for hydration.
7. Senior Football players over the age of 18 are required to attend the major functions \$10,000 Draw and The Team of the Decade and at least two other functions throughout the 2022 home and away season.
8. When you are wearing any Longwarry Football Netball Club attire you are representing our club. The club expects you to present yourself in a proper manner when wearing this attire.

ILLEGAL DRUG POLICY

Version 1 – This policy was approved by: the committee of Longwarry Football Netball club on the 4th of February 2019. The policy is due for review at the end of the 2019 playing season.

Introduction

Longwarry Football Netball Club does not allow the use, distribution or selling of illegal drugs by any club member or any visitors within our club's jurisdiction. This policy reflects our club's commitment to protecting the health, safety and wellbeing of all persons associated with the club and all persons in attendance at club activities.

Purpose of this policy

The purpose of this policy is to ensure the club committee and club members understand the club's position regarding illegal drugs and how it will respond to a drug-related incident within its jurisdiction.

Extent of this policy

This policy refers to illegal drugs only, which is defined as but not limited to "a substance that is not permitted to be taken or used according to state or national laws such as cannabis (marijuana), amphetamines (speed and "ice"), ecstasy, cocaine, heroin and a range of new psycho-active substances known as synthetic drugs."

This policy does not apply to pharmaceutical drugs or performance enhancing drugs bound by national laws (unless they are captured in the above definition).

When does this policy apply?

This policy applies whenever the individual is representing the club and/or is taking part in activities under the club's jurisdiction. This includes our club's facilities, games, matches, training, events, and trips organised by the club.

Private behaviour of members is not included in this policy as the club cannot be responsible for the behaviour of its members outside our club's jurisdiction; however, this policy will apply whenever an individual is wearing a part of the official club uniform which would identify them as being a representative of the club.

Who does this policy apply to?

All club members and visitors to our club.

Responsibilities

Our club will:

- Activate and comply with the policy.
- Promote the policy to everyone within our club.
- Promote and role model expected standards of behaviours at all times.
- Appoint and support appropriate persons such as a nominated club official to lead the initial response, investigation and action for all illegal drug-related incidents.
- Respond to breaches of this policy discreetly and in a timely manner.
- Investigate all apparent, or alleged, breaches of this policy and take action after all relevant facts and circumstances are known.
- Review this policy every year.
- Educate members on illegal drugs.
- Have a list of health service providers in our area who would be able to support an individual with a drug and/or alcohol-related issue.

Individuals will:

- Comply with the policy.
- Promote and role model expected standards of behaviours at all times.
- Be responsible and accountable for their behaviour.
- Alert club officials or the nominated club official with any concern about illegal drug use within the club.
- Honour our commitment to the health, safety and welfare of all of our members.

Responding to illegal drugs

Privacy

Where possible, the investigation of illegal drug-related concerns or incidents will remain confidential in line with our club's privacy policy.

The Privacy Policy of the Longwarry Football Netball Club is as follows:

- The Longwarry Football Netball Club will always act with discretion.
- Subject to its right to contact the Police if necessary, the Longwarry Football Netball Club will maintain the privacy of those involved as far as possible.

Investigating the concern or incident

The nominated club official will investigate all illegal drug-related concerns or incidents in a timely and discreet manner. Once all relevant facts and circumstances are known, the nominated club official will recommend appropriate approaches and/or disciplinary measures to the club committee based on the guiding principles outlined in this policy.

Response

When responding to an illegal drug-related concern or incident, the responses by our club will focus on the

safety and welfare of those directly and indirectly involved. All responses will reflect the club's duty of care to members and visitors.

All illegal drug-related concerns or incidents should be discussed with a nominated club official as soon as possible. The nominated club official will document the issue using the incident register and investigate the concern/incident further. In the event that a Welfare Officer is not available, a club official may substitute for them.

If illegal drugs are being distributed or sold on our club's premises by a member or visitor of any age, the nominated club official or President will contact the local police to seek their advice.

If illegal drugs are found within our club's jurisdiction the nominated club official or President will contact local police to seek their advice and so they can be disposed of safely.

Illegal drug use by a member under 18 years

Where the club identifies that a person under the age of 18 years is involved in illegal drug use the Longwarry Football Netball Club will:

- Inform the individual that a Welfare Officer will contact the parent or guardian to discuss the incident, if it is appropriate and safe to do so.
- Contact the parent or guardian to discuss, unless informing the parent or guardian would put the individual at risk of greater harm.
- In the case of a visitor in this instance, the Longwarry Football Netball Club will inform the visiting club.

Non-compliance with policy

Our club will respond to all breaches of this policy. Any disciplinary measures imposed under our policy must:

- Be fair and reasonable and will focus on the safety and welfare of those directly and indirectly involved.
- Be based on the evidence and information gathered and the impact on the club, other members, players, patrons, visitors and the community.
- Take into account the age and personal circumstances of the people involved.
- Take into account whether the incident involved personal use of an illegal drug and/or the supply of an illegal drug to other people.

Breaches of policy:

<p>If a member is found using drugs, or is affected by the use of illegal drugs under the club's jurisdiction:</p>	<ul style="list-style-type: none"> • The Longwarry Football Netball Club would ensure the safety and wellbeing of the individual is the first priority. • Seek out medical assistance, if required. • If required, contact next of kin. • If the individual (s) concerned is/are under 18, their parent or guardian would be informed immediately of the incident and of the consequences. • Ensure individual is safely transported to their home. • When the individual's health has returned to a normal state, the Welfare Officer will investigate and take appropriate action. • Where applicable, the individual (s) may be referred to a local health service provider. • In the case of a visitor, the Longwarry Football Netball Club will inform the visiting club, or ask the individual not to return to the club grounds.
<p>If a member is found in possession of an illegal drug, the following will occur:</p>	<ul style="list-style-type: none"> • The individual (s) will be asked to hand-over the substance and the club will follow the procedures for handling illegal drugs in its jurisdiction. • The Longwarry Football Netball Club will contact the local police to seek their advice. • Consequences for the individual (s) will depend on the circumstances or severity. • Where applicable, the individual (s) may be referred to a local health service provider. • If the individual (s) concerned is/are under 18, their parent or guardian would be informed immediately of the incident and of the consequences, unless informing the parent or guardian would put the individual at risk of greater harm. • In the case of a visitor, the Longwarry Football Netball Club will inform the visiting club, or ask the individual not to return to the club grounds.
<p>If a member sells or distributes illegal drugs in the club's jurisdiction, the following will occur:</p>	<ul style="list-style-type: none"> • The police will be contacted to seek their advice. • Consequences for the individual (s) will depend on the circumstances or severity. • Where applicable, the individual (s) may be referred to a local health service provider. • The club will appoint a senior person to act as a mentor to a suspended individual (s) for a nominated period of time and to assist them to reintegrate with the club, if applicable. • If the individual (s) concerned is/are under 18, their parent or guardian would be informed immediately of the incident and of the consequences, unless informing the parent or guardian would put the individual at risk of greater harm. • In the case of a visitor, the Longwarry Football Netball Club will inform the visiting club or ask the individual not to return to the club grounds.

***All contact with the media related to a drug-related allegation or incident within its jurisdiction will be managed by the club's official spokesperson / President.
